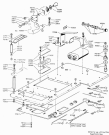


FIGURE 1. 1958 FORD MUSTANG V8 ENGINE AND CHASSIS

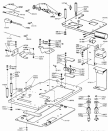


FIGURE 1. 2000 cc ENGINE WITH CRANKSHAFT AND PISTON

FIGURE 3. FRONT SUSPENSION AND STEERING SYSTEM (FRONT VIEW), LOWER AND LOWER CONTROL ARM

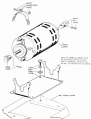
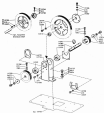


FIGURE 1. MICROSCOPE ASSEMBLY WITH AN OILY FLUORESCENCE EXCITATION FILTER

FIGURE 2. BICYCLE (SAATCHI & SAATCHI)

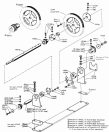


FIGURE 1. CHASSIS, WHEEL, SUSPENSION ASSEMBLY DRAWING

FIGURE 2. MODELING AND ASSEMBLY WITH CALL-OUTS IN SOLIDWORKS

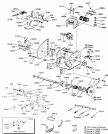


FIGURE 1. STATE AND LOCAL BOUNDARY NETWORK
